# PeopleAdmin Product Suite Accessibility **Section 508**

The purpose of this Voluntary Product Accessibility Template, or VPAT, is to assist Federal contracting officials and other buyers in making preliminary assessments regarding the availability of commercial "Electronic and Information Technology" products and services with feature that support accessibility.

The first table of the Template provides a summary view of the section 508 Standards, identifying which subsections are applicable to the products available from PeopleAdmin. The subsequent tables provide more detailed views of each applicable subsection.

There are three columns in each table. Column one of the Summary Table describes the subsections of subparts B and C of the Standards. The third column contains any additional remarks and explanations regarding the product. In the subsequent tables, the first column contains the lettered paragraphs of the subsections. Fully Supported.	All functionality of the content is operable through a keyboard interface without requiring specific timings for individual keystrokes,  SelectSuite allows the user to TAB (use the keyboard) between various controls for navigation. This functionality does not cause the page to suddenly change content.
(b) Applications shall not disrupt or disable activated features of other products that are identified as accessibility features, where those features are developed and documented according to industry standards. Applications also shall not disrupt or disable activated features of any operating system that are identified as accessibility features where the application programming interface for those accessibility features has been documented by the manufacturer of the operating system and is available to the product developer.	Fully Supported.	The product does not disable any accessibility features of the underlying browser platform or operating system.
(c) A well-defined on-screen indication of the current focus shall be provided that moves among interactive interface elements as the input focus changes. The focus shall be programmatically exposed so that assistive technology can track focus and focus changes.	Partially Supported.	A well-defined, on-screen indication of the current focus is not evident for every navigable element, on every page.  While most buttons in SelectSuite have rollover effects, few change state based on focus. When using the TAB key to move from one element to another, it should be obvious where the focus is on your screen at any given moment.
(d) Sufficient information about a user interface element including the identity, operation and state of the element shall be available to assistive technology. When an image represents a program element, the information conveyed by the image must also be available in text.	Fully Supported.	PeopleAdmin supports form elements with a "label" or "legend" attribute to help correlate the interface element(s) with the label, and does not substitute images for form elements.  Components within SelectSuite are generally very consistent from page to page. For example, functionality for a SEARCH button on one page will be consistent on other pages.
(e) When bitmap images are used to identify controls, status indicators, or other programmatic elements, the meaning assigned to those images shall be consistent throughout an application's performance.	Fully Supported.	Buttons, controls and status indicators are generally represented with coded elements as a best practice. Images are generally not used for this purpose.

(f) Textual information shall be provided through operating system functions for displaying text. The minimum information that shall be made available is text content, text input caret location, and text attributes.	Fully Supported.	The PeopleAdmin Product Suite uses the native browser functions to display text content, location, and attributes.
g) Applications shall not override user selected contrast and color selections and other individual display attributes.	Fully Supported.	The PeopleAdmin Product Suite does not override user selected color and contrast settings.  The visual style of customer controlled content or "snippets" is not controlled or checked for contrast. Customers are able to enter whatever color text they wish.
h) When animation is displayed, the information shall be displayable in at least one non-animated presentation mode at the option of the user.	Not Applicable.	The PeopleAdmin Product Suite does not use animated displays.  Generally SelectSuite does not move, blink, autoscroll, or auto-update any information.
(i) Color coding shall not be used as the only means of conveying information, indicating an action, prompting a response, or distinguishing a visual element.	Fully Supported.	The PeopleAdmin Product Suite does not use color as the sole means of conveying any meaningful information. Color is not used as the only visual means of conveying information, indicating an action, prompting a response, or distinguishing a visual element. The product uses color for aesthetic purposes.
(j) When a product permits a user to adjust color and contrast settings, a variety of color selections capable of producing a range of contrast levels shall be provided.	Not Applicable.	The PeopleAdmin Product Suite does not provide any adjustments to color and contrast settings, and does not interfere with these functions in the browser or operating system.
(k) Software shall not use flashing or blinking text, objects, or other elements having a flash or blink frequency greater than 2 Hz and lower than 55 Hz.	Fully Supported.	The PeopleAdmin Product Suite does not use any flashing or blinking elements on the site. Generally SelectSuite does not move, blink, autoscroll, or auto-update any information.

(b) Equivalent alternatives for any multimedia presentation shall be synchronized with the presentation.	Fully Supported.	The PeopleAdmin Product Suite – in its preconfigured state, does not contain any multimedia presentations.
(c) Web pages shall be designed so that all information conveyed with color is also available without color, for example from context or markup.	Fully Supported.	The PeopleAdmin Product Suite does not use color as the sole means of conveying any meaningful information. (e) Redundant text links shall be provided for each active region of a server-side image map.	Not Applicable.	The PeopleAdmin Product Suite does not use any server-side image maps.
(f) Client-side image maps shall be provided instead of server-side image maps except where the regions cannot be defined with an available geometric shape.	Not Applicable.	The PeopleAdmin Product Suite – in its preconfigured state – does not contain any client-side image maps.
(g) Row and column headers shall be identified for data tables.	Fully Supported	Columns on data tables contain appropriately marked headers. Rows headers are not necessary in the context in which tabular data is provided.
(h) Markup shall be used to associate data cells and header cells for data tables that have two or more logical levels of row or column headers.	Fully Supported	Table rows and columns are not generally complex; they are not embedded with more than one logical level.

Limited Support.	SelectSuite utilizes many scripts to enhance the functionality of the product and to be able to offer a modern and effective yet competitive product. Generally these scripts offer functionality, not information.     Standard form controls are generally used. Custom, script-driven interface elements are avoided. That said, not all scripts are identified with functional text that can be read by Assistive Technology.
(m) When a web page requires that an applet, plug-in or other application be present on the client system to interpret page content, the page must provide a link to a plug-in or applet that complies with §1194.21(a) through (I).	Fully Supported.	PeopleAdmin converts certain documentation uploaded by site users into PDF format, and site users must install a PDF reader to utilize full site functionality. The PeopleAdmin product allows its customers full flexibility in placing any content – or links to external content – on their site.
(n) When electronic forms are designed to be completed on-line, the form shall allow people using Assistive Technology to access the information, field elements, and functionality required for completion and submission of the form, including all directions and cues. (p) When a timed response is required, the user shall be alerted and given sufficient time to indicate more time is required.	Fully Supported.	Users are notified that they will be logged out without further activity, and given an option to extend their time.

(c) Support services for products shall accommodate the communication needs of end-users with disabilities.	Fully Supported.	PeopleAdmin does not provide support to end users, other than those identified as site configuration administrators. PeopleAdmin will work to accommodate the needs of any users it supports.
